

DATA MANAGEMENT NOTIFICATION REGARDING THE MANAGEMENT OF THE DATA OF NATURAL PERSONS (DATA SUBJECTS) BY AQ ANTON KFT. AND THE RIGHTS OF THE DATA SUBJECTS

Effective as of 25th May 2018 INTRODUCTION

REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as Regulation) stipulates that Data Controller shall take appropriate measures to provide any information relating to processing to the data subject in a concise, transparent, intelligible and easily accessible form, using clear and plain language, as well as Data Controller shall facilitate the exercising of the rights of data subject.

The obligation to notify the data subject in advance is stipulated by Act CXII of 2011 on The Right to Informational Self-determination and the Freedom of Information as well.

Through the notification below, we comply with this statutory obligation.

We publish the notification on the website of our company, or we send it to the data subject upon his/her explicit request.

- 2. **Legal basis of the data management**: the effective Act CXII of 2011 ("Privacy Act"), Article 6(1) of Regulation (EU) 2016/679 Of the European Parliament and of the Council effective from 25th May 2018 ("GDPR"), as well as the effective legal, accounting and taxation provisions. In the following, we will present the details of the data management according to the specific data management purposes.
- 3. Data management purposes: as specified in the chart to be found at the end of this notification
- 4. **Period of storage of the personal data**: detailed in respect of each data management purpose in the chart to be found at the end of this notification
- 5. **Data security**: In order to ensure protection of the personal data, our Company maintain an appropriate information security policy in effect, and it restricts access to the data by determining the authorization levels. In order to ensure the security of the information technology systems, our company protects those by firewall, as well as uses virus detection and anti-virus programme. Our Company ensures the controlling of the incoming and outgoing communication conducted via electronic means.

- 7. **Rights and opportunities of legal remedy related to data management**: The natural person may request the following from the data controller:
- may request information regarding the management of his/her personal data,
- may initiate the rectification of his/her personal data,
- except for mandatory data management, may request the erasure of his/her personal data,
- may object to the management of his/her personal data,

Data Controller shall provide information upon the request or inquiry of the natural person, within the deadline specified by the prevailing laws. If necessary, taking into consideration the complexity of the request and the number of requests, this deadline may be extended by an additional two months. Data Controller shall inform the data subject of any such extension within one month of receipt of the request, together with the reasons for the delay. Where the data subject makes the request by electronic form means, the information shall be provided by electronic means where possible, unless otherwise requested by the data subject. If Data Controller does not take action on the request of the data subject, the Data Controller shall inform the data subject without delay and at the latest within one month of receipt of the request of the reasons for not taking action and on the possibility of lodging a complaint with a supervisory authority and seeking a judicial remedy.

- 8. Our Company is not obliged to appoint a data protection officer.
- 9. The present data protection notification is **available** at the **www.anton.hu** website. Our Company may modify the present notification unilaterally and in respect of the future, of which modification the data subjects will be notified by the company through the website of the company.
